AT THAT POINT, THE PARTICIPANT WILL NEED TO MAKE AN APPOINTMENT TO MEET WITH HEREFORD SPORTS & WELLNESS OFFICIALS TO DISCUSS THE MATTER BEFORE BEING ALLOWED TO PARTICIPATE IN ANY FUTURE PROGRAMS.
IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN ANY WAY IN A HEREFORD SPORTS & WELLNESS ACTIVITY ("ACTIVITY") I, FOR MYSELF, FOR PERSONAL REPRESENTATIVES, ASSIGNS, HEIRS, AND NEXT OF KIN:
1. ACKNOWLEDGE, AGREE, AND REPRESENT THAT I UNDERSTAND THE NATURE OF HEREFORD SPORTS & WELLNESS ACTIVITIES AND THAT I, AM QUALIFIED, IN GOOD HEALTH, AND IN PROPER PHYSICAL CONDITION TO PARTICIPATE IN SUCH ACTIVITY. I FURTHER AGREE AND WARRANT THAT IF AT ANY TIME I BELIEVE CONDITIONS TO BE UNSAFE, I WILL IMMEDIATELY DISCONTINUE FURTHER PARTICIPATION IN THE ACTIVITY.
2.
