ALL LANGUAGE IN THIS DOCUMENT REFERS TO AN INDIVIDUAL "PARTICIPANT". IN THE CASE OF A MINOR UNDER THE AGE OF 18, "PARTICIPANT" REFERS TO THE PARENT OR LEGAL GUARDIAN FOR SAID INDIVIDUAL. PLEASE CHECK ONE OF THE FOLLOWING:

THE WAIVER ASSOCIATED WITH THIS ACCOUNT SHALL REMAIN IN EFFECT PERMANENTLY UNLESS THE PARTICIPANT NOTIFIES THE HEREFORD SPORTS & WELLNESS OFFICE, IN WRITING, THAT THEY NO LONGER WISH TO AGREE TO THE WAIVER. AT THAT POINT, THE PARTICIPANT WILL NEED TO MAKE AN APPOINTMENT TO MEET WITH HEREFORD SPORTS & WELLNESS OFFICIALS TO DISCUSS THE MATTER BEFORE BEING ALLOWED TO PARTICIPATE IN ANY FUTURE PROGRAMS.

IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN ANY WAY IN A HEREFORD SPORTS & WELLNESS ACTIVITY ("ACTIVITY") I, FOR MYSELF, FOR PERSONAL REPRESENTATIVES, ASSIGNS, HEIRS, AND NEXT OF KIN:

1. ACKNOWLEDGE, AGREE, AND REPRESENT THAT I UNDERSTAND THE NATURE OF HEREFORD SPORTS & WELLNESS ACTIVITIES AND THAT I, AM QUALIFIED, IN GOOD HEALTH, AND IN PROPER PHYSICAL CONDITION TO PARTICIPATE IN SUCH ACTIVITY. I FURTHER AGREE AND WARRANT THAT IF AT ANY TIME I BELIEVE CONDITIONS TO BE UNSAFE, I WILL IMMEDIATELY DISCONTINUE FURTHER PARTICIPATION IN THE ACTIVITY.

2. ## AGE AND/OR GRADE-BASED DISCREPANCIES

AT ANY TIME, AT THE SOLE DISCRETION OF HEREFORD SPORTS & WELLNESS, WE RESERVE THE RIGHT TO REQUIRE THE PARENT AND/OR LEGAL GUARDIAN TO SUBMIT AN ORIGINAL BIRTH CERTIFICATE, A CURRENT REPORT CARD, AND/OR A CURRENT SCHOOL-VALIDATED CLASS SCHEDULE TO VERIFY THE ACCURATE AGE/GRADE. FOR ADULT PARTICIPANTS, WE RESERVE THE RIGHT TO REQUIRE THE PARTICIPANT TO SUBMIT ONE OR MORE OF THE FOLLOWING VALID FORMS OF IDENTIFICATION: 1) DRIVER'S LICENSE FROM A U.S. STATE, 2) FEDERAL OR STATE ID CARD, 3) MILITARY ID CARD, 4) U.S. PASSPORT.

- PLEASE USE GOOD SPORTSMANSHIP.
- THE USE OF DRUGS, ALCOHOL, VAPING, OR TOBACCO IN ANY FORM IS NOT PERMITTED WHILE ATTENDING ANY HEREFORD SPORTS & WELLNESS EVENT.
- NO FIREARMS OR WEAPONS WILL BE PERMITTED AT ANY HEREFORD SPORTS & WELLNESS EVENT.

AT ANY TIME, AT THE SOLE DISCRETION OF HEREFORD SPORTS & WELLNESS, VIOLATION OF THE CODE OF CONDUCT IS SUBJECT TO SUSPENSION OR EXPULSION FROM OUR PROGRAM.
