THE WAIVER ASSOCIATED WITH THIS ACCOUNT SHALL REMAIN IN EFFECT PERMANENTLY UNLESS THE PARTICIPANT NOTIFIES THE HEREFORD SPORTS & WELLNESS OFFICE, IN WRITING, THAT THEY NO LONGER WISH TO AGREE TO THE WAIVER. AT THAT POINT, THE PARTICIPANT WILL NEED TO MAKE AN APPOINTMENT TO MEET WITH HEREFORD SPORTS & WELLNESS OFFICIALS TO DISCUSS THE MATTER BEFORE BEING ALLOWED TO PARTICIPATE IN ANY FUTURE PROGRAMS.
IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN ANY WAY IN A HEREFORD SPORTS & WELLNESS ACTIVITY ("ACTIVITY") I, FOR MYSELF, FOR PERSONAL REPRESENTATIVES, ASSIGNS, HEIRS, AND NEXT OF KIN:
1. ACKNOWLEDGE, AGREE, AND REPRESENT THAT I UNDERSTAND THE NATURE OF HEREFORD SPORTS & WELLNESS ACTIVITIES AND THAT I, AM QUALIFIED, IN GOOD HEALTH, AND IN PROPER PHYSICAL CONDITION TO PARTICIPATE IN SUCH ACTIVITY. I FURTHER AGREE AND WARRANT THAT IF AT ANY TIME I BELIEVE CONDITIONS TO BE UNSAFE, I WILL IMMEDIATELY DISCONTINUE FURTHER PARTICIPATION IN THE ACTIVITY.
2. FULLY UNDERSTAND THAT: (A) HEREFORD SPORTS & WELLNESS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (B) THESE RISKS AND DANGERS MAY BE CAUSED BY MY OWN ACTIONS OR INACTION'S, THE ACTIONS OR INACTION'S OF OTHERS PARTICIPATING IN THE ACTIVITY, THE CONDITION IN WHICH THE ACTIVITY TAKES PLACE, OR THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (C) THERE MAY BE OTHER RISK AND SOCIAL AND ECONOMIC LOSSES EITHER NOT KNOWN TO ME OR NOT READILY FORESEEABLE AT THIS TIME; AND I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I INCUR AS A RESULT OF MY PARTICIPATION.

AGE AND/OR GRADE-BASED DISCREPANCIES  AT ANY TIME, AT THE SOLE DISCRETION OF HEREFORD SPORTS & WELLNESS, WE RESERVE THE RIGHT TO REQUIRE THE PARENT AND/OR LEGAL GUARDIAN TO SUBMIT AN ORIGINAL BIRTH CERTIFICATE, A CURRENT REPORT CARD, AND/OR A CURRENT SCHOOL-VALIDATED CLASS SCHEDULE TO VERIFY THE ACCURATE AGE/GRADE.
